<p>What is the overall deductible?</p>	<p>For Tier I (Salem Health Hospitals & Clinics and facilities): None; for Tier II (Connexus network): \$250 individual / \$500 family; for Tier III (Connexus network): \$500 individual / \$1,000 family; for Tier IV (out-of-network providers) : \$750 individual / \$1,500 family.</p>	<p>Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes.
