I. Description

Essential tremor is a nervous system condition, that causes involuntary and rhythmic shaking. A tremor is defined as an involuntary, rhythmic, and oscillatory movement of a body part. It is the most common movement disorder. It's a postural tremor with an onset anywhere between the second and sixth decades of life, and its prevalence increases with age. It's slowly progressive over a period of years. A postural tremor is observed when a patient tries to maintain a posture against gravity, such as holding the arms out in front of the body.

The specific pathophysiology remains unknown. Essential tremors occur sporadically or can be inherited. The frequency of essential tremors depends on the body segment that is affected. Proximal segments are affected at a lower frequency, and distal segments are affected at a higher frequency. Although typically a postural tremor, an essential tremor may occur at rest in severe and very advanced cases. It most commonly affects the hands but can also affect the head, voice, tongue, and legs (Charles et al 1999). Trembling occurs most often in the hands, especially when doing simple tasks such as drinking from a glass or tying shoelaces. The medically refractory essential tremor is one of the most common neurological diseases and annually affects millions of people in the US.

Magnetic resonance-guided focused ultrasound (MRgFUS) is a procedure used for treatment of benign and malignant tumors. Ultrasound is a form of energy that can pass through skin, muscle, fat, and other soft tissue.

II. Criteria: CWQI HCS

- A. Magnetic resonance (MR)-guided focused ultrasound is considered medically necessary for the treatment of <u>medicine refractory essential tremors</u> when **ALL** of the following criteria are met;
 - a. Member with medicine-refractory tremor defined as refractory to at least two trials of medical therapy, including at least one first-line agent (e.g., propranolol or primidone)
 - b. Member with either a moderate to severe postural tremor or an intention tremor of the dominant hand that affects the activities of daily living (ADLs)
 - c. And one of the following;

- i. Member not eligible for deep brain stimulation (DBS) or has failed DBS, but has no retained cranial implants
- ii. Have been evaluated by a multidisciplinary team, and considered this is the best course of treatment
- B. MRgFUS is considered investigational for all the following;
 - a. Treatment of medication refractory tremor dominant Parkinson's disease
 - b. Treatment of uterine fibroids
 - c. Treatment of other tumors (e.g., prostate cancer, brain cancer, desmoid tumors)
