I. Description

Endoscopic sinus surgery is a procedure designed to open the natural drainage pathways of the sinuses to restore their function and health. It is often used for patients with acute or chronic rhinosinusitis when medical treatment has been unsuccessful. In chronic sinusitis, the sinuses are unable to drain adequately due to inflammation of the narrow drainage pathways. This results in nasal secretions that can become trapped in the sinuses and become chronically infected.

Post-operative debridement is a crucial aspect optimizing results in endoscopic sinus surgery. It is a measure suggested to help patients recover. Debridements are suggested to be an essential part of maintaining sinus ostium patency, reducing pooling of mucus, preventing infection, and critical to long term success. Debridement of the sinus cavity is a procedure performed following endoscopic sinus surgery (ESS). The procedure involves transnasal insertion of the endoscope for visualization and parallel insertion of various instruments for the purpose of removal of postsurgical crusting, residua of dissolvable spacers, coagulum, early synechiae, or devitalized bone or mucosa. It may also be used to remove crusts or debris in patients with longstanding chronic sinusitis with persistent sinonasal inflammation who have undergone sinus surgery in the past. It is performed under local or general anesthesia in a suitable office space or operating room.

II. Criteria:

- A. Moda Health considers medically necessary **up to 3** post-operative nasal endoscopies with debridement after sinus surgery or sinus surgery combined with nasal surgery within the six weeks following surgery
- B. Moda Health considers NOT medically necessary additional debridement procedures within the six weeks following the sinus surgery other than those indicated in II. A
- C. Moda Health considers NOT medically necessary any debridement procedures performed outside of the six week post-operative period, unless there are well documented clinical situations that warrant their need. Additional debridement would be considered for any of the following (not an inclusive list);
 - a. Allergic mucin
 - b. Lateralized middle turbinate with ostial obstruction
 - c. Persistent crusting
 - d. Recurrent polyps
 - e. Retained fungal material
 - f. Synechiae obstructing sinus ostia

D. Moda health considers NOT medically necessary post-operative nasal endoscopy with debridement after nasal surgery such as septoplasty, turbinectomy etc
