Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Tier 1 and Tier 2: preventive care and children's dental check-up services are covered before you meet your deductible . For all Tiers: value and select prescription medications, children's routine eye exams and glasses, adult vision care services, and hearing aid services are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply.
