| What is the overall <u>deductible</u> ? | For <u>network providers</u> \$1,000 individual / \$2,000 family; for <u>out-of-network providers</u> \$2,000 individual / \$4,000 family. | Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> . |
| Are there services covered before you meet your <u>deductible</u> ? | Yes. Examples of some services: In-network office visits for primary care, <u>specialist</u> and <u>urgent care</u> , virtual care visits, <u>preventive care</u> , office visits for outpatient mental health and chemical dependency, outpatient <u>diagnostic test</u> , outpatient rehabilitation and habilitation, as well as most in and out of network prescription medications are covered before you meet your <u>deductible</u> . | This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount.
