Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. In-network <u>preventive care</u> , primary care, <u>specialist</u> , <u>urgent care</u> , virtual care visits, office visits for outpatient mental health and substance use disorder, outpatient <u>rehabilitation services</u> and <u>habilitation services</u> , and children's vision care as well as in and out of network value and select medications are covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes.
