### I. Length of Authorization

Initial coverage will be provided for 6 months and may be renewed annually thereafter.

### II. Dosing Limits

#### A. Quantity Limit (max daily dose) [Pharmacy Benefit]:

- Kanuma 20 mg/10 mL single-use vials: 68 vials per 28 day supply

#### B. Max Units (per dose and over time) [Medical Benefit]:

- 340 billable units once weekly

### III. Initial Approval Criteria

Coverage is provided in the following conditions:

#### Lysosomal Acid Lipase (LAL) deficiency †

- Diagnosis has been confirmed by either biallelic pathogenic variants in *LIPA* or deficient LAL enzyme activity in peripheral blood leukocytes, fibroblasts, or dried blood spots; **AND**
- Patient is at least 1 month old

† FDA Approved Indication(s)

### IV. Renewal Criteria

Coverage can be renewed based upon the following criteria:

- Patient continues to meet the criteria identified in section III; **AND**
- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include: hypersensitivity reactions (anaphylaxis, abdominal pain, fever, chills, pruritus, rash, vomiting), etc. ; **AND**
- Treatment has resulted in clinical benefit; for example:
  - Improvement in weight-for-age z-scores for patients exhibiting growth failure
  - Improvement in LDL
  - Improvement in HDL
  - Improvement in triglycerides
  - Improvement of AST or ALT

## V. Dosage/Administration

Indication	Dose
LAL deficiency	<u>Pediatric &amp; Adult patients:</u> <ul style="list-style-type: none"><li>1 mg/kg administered once every other week as an IV infusion</li></ul>
	<u>Rapidly progressive disease presenting within the first 6 months of life:</u> <ul style="list-style-type: none"><li>1 mg/kg administered once weekly as an IV infusion</li><li>May increase to 3 mg/kg once weekly for patients who do not achieve an optimal clinical response</li></ul>
