Keeping expenses in check: the ODS Preferred Drug program

Part III

In our last two issues of Member Matters, we have looked more closely at the use of prescription drugs to find the source of increasing costs. We have found that direct-to-consumer advertising of brand name drugs, more new and expensive drugs and the aging population all contribute to a rise in demand and cost of many prescriptions.

As prices for prescriptions go up, what can your

health plan do to keep prescription expenses in check? One way

ODS is addressing this trend of rising prices is with the three-tier Preferred Drug

The three-tier system has major implications for cost containment,' says Robin Richardson, director of Pharmaceutical Programs at ODS Health Plans. "It creates an incentive to use clinically effective less expensive drugs, while continuing to give members choices.'

The ODS Preferred Quick Reference Drug Chart lists the three tiers: Generic, Preferred Brand and Non-Preferred Brand. You can find the chart on the **ODS** website:

The three-tier Preferred Drug Program groups medications in three different lists called "tiers." Each one of the tiers has a different copay the member must pay. Tier one lists only generic drugs and usually has the lowest of the three copays. Tier two contains brand name drugs that are considered Preferred

Drugs and has a slightly higher copay than the generic list. This Preferred Drug tier lists medications that are considered safe and effective and are available to members at the most affordable price. The third tier lists the more expensive, Non-Preferred brand name drugs and the copay is the highest of the three tiers. Drugs listed in the Non-Preferred tier always have clinically effective, lower cost alternatives listed as

Generic or Preferred. Not all drugs are currently available on the Preferred Quick Reference Drug Chart. While drugs used to treat allergies and high blood pressure are included on the list, drugs used to treat less common diseases like multiple sclerosis or cancer, are not on the list. This is because there are many medication choices that have been proven equally safe and effective for

treatment of allergies and high blood pressure. However, drug treatment choices for less common diseases are more limited. For this reason, drugs not found on the list are generally considered Preferred Drugs.

Systems like the ODS Preferred **Drug Program helps** members understand the correlation between drug costs and copays.

'We've had a good response to this system," says Richardson.

"It has been a particularly effective way to encourage patients and physicians to sit down and talk about prescriptions, and this helps

ensure that the medications prescribed are medically necessary. It also doesn't penalize people with chronic health conditions who require long-term management with medication."
